Californians are tired of high and increasing health care costs. The state of California has enacted a measure to establish the Office of Health Care Affordability to set cost targets for hospitals, physician organizations, payers, and others — and to penalize those that exceed their targets. In addition, the office will conduct a market impact review for certain health care mergers, acquisitions, affiliations, or other transactions that entail material changes to ownership, operations, or governance of hospitals, physician organizations, payers, and others. These transactions cannot be implemented without a written waiver from the office or until 60 days after the office issues its final report. Our speaker will explain the role of the office, its authority, the timeline for implementation, and the expected impact on the health care marketplace.

California needs additional healthcare professionals to meet the demand for primary care. To meet this need, the state has enacted measures loosening the supervision requirements of non-physician professionals and expanding the scope of practice of nurse practitioners. This presentation will examine the current state of physician supervision requirements in California, how they have changed recently, and what these changes mean for healthcare professionals and facilities, including the corporate practice of medicine.

In response to the decision in *California Advocates for Nursing Home Reform (CANHR) v. Smith* holding that the interdisciplinary team consent process set forth in Health and Safety Code Section 1418.8 was constitutionally deficient, the California Department of Aging is establishing a brand-new Office of the Long-Term Care Patient Representative. This office will connect public patient representatives to residents who lack decision-making capacity and have no family or friend to speak or act on their behalf. This presentation will provide an overview of the issues involved in the *CANHR v. Smith* case, recently-updated statutory language, and the role of the new office.

Physician Well-Being and Burnout

Practitioner burnout has been an ongoing issue in the healthcare industry, and COVID-19 further increased the stressors on emotional well-being. These stressors have the potential of adversely impacting practitioner conduct and already have pushed many practitioners into leaving their practices. So what is the solution to burnout? For many institutions, well-being committees could become part of the answer. In this program, we will discuss the value and legal parameters of Medical Staff well-being committees; how to structure and define the scope of a meaningful, useful, and proactive well-being committee; and emerging ideas in the industry for addressing practitioner well-being. We will also discuss Stark law considerations when developing wellness programs to address practitioner well-being and burnout.
